

# TERMS OF REFERENCES FOR THE CONTRIBUTION OF THE AFRICAN SECURITY SECTOR NETWORK TO BUILDING AFRICAN UNION CAPACITIES IN SSR

## I. BACKGROUND:

Security sector reform (SSR) has been recognized by the African Union (AU) and the United Nations (UN) as an essential item on the agenda of peace, security and sustainable development in Africa. In January 2008, the Assembly of the African Union (AU) Heads of State and Governments encouraged the AU Commission (AUC) to develop a comprehensive AU policy framework on security sector reform. The AUC has completed the process of developing this Policy Framework, which was presented to and adopted by AU Heads of States and Government at the AU Summit in January 2013. However, as recognized by the AUC itself, together with a number of Regional Economic Communities and AU field liaison offices, the AU must continue to develop its capacities to implement this policy.

The SSR Unit in the UN Department of Peacekeeping Operations and the SSR capacity in the United Nations Office to the African Union (UNOAU) recently achieved a number of key milestones in the development of a UN approach to SSR, which will be of value to the AUC as it develops its own framework and approach. The European Union (EU) is also committed to supporting this important endeavour. To this end, the AU, the UN and the EU have elaborated a multi-year, multi-donor programme entitled "Building African Union Capacities in SSR", which will be implemented with technical and operational support from United Nations Office for Project Services (UNOPS) and the African Security Sector Network (ASSN).

This ASSN support to the program is in line with previous arrangements between the AU, the UN and ASSN. In November 2010, H.E. Ramtane Lamrama, Commissioner for Peace and Security in the AUC and Mr. Dmitry Titov, Assistant Secretary-General for Rule of Law and Security Institutions in UN DPKO co-signed a letter of agreement with the ASSN requesting technical support for a number of activities described in this proposal, including the development of policy tools (e.g. code of conduct for African security institutions, a manual on SSR best practices in Africa, guidance on harmonization of national security legislation); joint SSR assessments in mutual priority countries; the preparation of operational guidance materials and training and advocacy based on the continental SSR policy framework, among other activities.

#### II. JUSTIFICATION OF CONSULTANCY:

The ASSN is a network of SSR experts in Africa and elsewhere, which aims to achieve well governed national security sectors and more effective collective peace and security arrangements. The ASSN has provided significant support to the AU and the UN in the area of SSR including by supporting the organization of a regional workshop on SSR in March 2009; coordinating the preparation of 9 background policy papers to inform the draft AU SSR Policy Framework; supporting the validation workshop on the AU's emerging approach to SSR in December 2009; facilitating events on "African Perspectives on SSR" co-hosted by the Permanent Missions of Nigeria and South Africa with support from DPKO SSR Unit in May 2010; and providing significant logistic and substantial support for two experts drafting sessions on the AU SSR Policy Framework in May and October 2010. In addition, ASSN and the AUC have concluded a Memorandum of



Understanding regarding ASSN support for the secondment of an SSR Advisor to the AUC; provision for two SSR Programme Assistants to assist the AU SSR project; and the provision of office equipment for AUC SSR staff. Given its access to a vast network of specialists in a number of areas of SSR-related expertise, and its on-going support, the African Union Commission has requested ASSN to provide technical and substantive support to the project.

# III. <u>DEVELOPMENT OBJECTIVE:</u>

The <u>overall objective</u> of "Building AU capacities in Security Sector Reform (SSR)" is "to build African Union capacities in the key peacebuilding area of SSR through a partnership between the African Union, the United Nations Department of Peacekeeping Operations and the European Union with the aim of better positioning the AU to support national authorities with effective SSR implementation to advance social justice and sustainable peace."

ASSN will provide critical technical support to meet these objectives as described below and will also participate as a full member of the project Steering Committee.

#### IV. SPECIFIC OBJECTIVE(S):

The <u>specific objectives</u> for this project are directly derived from the AU multi-year SSR programme and include:

- **A.** Facilitating the process for the production, adoption and promulgation of the AU SSR Policy Framework and related instruments, in accordance with AU Summit decisions and based on the principle of African ownership;
- **B.** Supporting and facilitating capacity-building within the AU for SSR;
- **C.** Strengthening AUC and field-based consultation and collaboration between the AU, the UN, the EU and other partners in SSR and;
- **D.** Institutionalizing the AU's input into the elaboration of a global approach to SSR as well as the development and deployment of tools to implement this approach.
- **E.** Ensuring that the AU's emerging approach to SSR informs and is informed by the SSR-related policies and practices of the AU Member States and Regional Economic Communities.

The specific objective of the ASSN participation in the programme is to provide technical support in producing the outputs associated with Specific Objectives A and to participate in the activities contributing to Objective C, as elaborated below. The ASSN will be directly responsible for drafting guidance documents and tools on designated issues to support the dissemination and implementation of the AU SSR Policy Framework. The ASSN will contribute to other project objectives and provide strategic advice on the project through its participation in the project Steering Committee.

#### V. OUTPUTS:

ASSN will be directly responsible for producing the outputs associated with Specific Objectives A and participation in Objective C, as elaborated below.

<u>Specific objective (A)</u>: Facilitating the process for the production, adoption and promulgation of the AU SSR Policy Framework and related instruments, in accordance with AU Summit decisions and based on the principle of African ownership.

Budget provision for all the above outputs is for at least one consultative validation workshop. If savings are made, more than one workshop should take place.

**Specific Objective (C):** Strengthening AUC and field-based consultation and collaboration between the AU, the UN, the EU and other partners in SSR.
